<p><b>Telephone Bomb Threat against a 3<sup>rd</sup> Party/other location</b></p>	<p>Do you have defined procedures in place in the event of these threats:</p> <ul style="list-style-type: none"> <li>! Does your business know how to deal with a telephone bomb threat directed at a 3<sup>rd</sup> party / other location?</li> <li>! Do your staff know what questions to ask?</li> <li>! How would this impact on you being able to continue to do business?</li> </ul>	<ul style="list-style-type: none"> <li>! Ensure all staff receive basic training and awareness on the business procedures for dealing with this along with clearly defined roles &amp; responsibilities</li> <li>! <p><b>Telephone Bomb Threat against your premises</b></p>	<p>In addition to the above:</p> <ul style="list-style-type: none"> <li>! Do your staff know who to inform?</li> <li>! Do you have a defined plan &amp; procedures to search your premises?</li> <li>! Do you have defined evacuation procedures?</li> <li>! When was the last time your evacuation and search procedures were tested?</li> </ul>	<ul style="list-style-type: none"> <li>! Procedures to be included in staff training &amp; awareness sessions</li> <li>! Incorporate lessons learnt from your training sessions into the security plan</li> </ul>	<p>General guidance on the CPNI website about <a href="#">search planning</a>.</p>

<p><b>Postal Threats e.g. powder, IED (improvised explosive device)</b></p>	<p>Do you have defined procedures for dealing with suspect packages:</p> <ul style="list-style-type: none"> <li>! Do your mail handlers know how to deal with suspect packages and who to contact?</li> </ul>	<ul style="list-style-type: none"> <li>! <p><b>CT incident near your premises</b></p>	<p>Do you have a Business Continuity Plan (BCP) in place:</p> <ul style="list-style-type: none"> <li>! Do you have a time of crisis communication strategy?</li> <li>! Can you contact your staff in the event of an incident?</li> <li>! Do you have procedures to invoke your plan?</li> <li>! Do you have key personnel to make decisions?</li> <li>! Do you have alternative locations to work from?</li> <li>! Do you have an alternative rendezvous point if the main premises are inaccessible?</li> <li>! Do you have suppliers that also need to consider their BCP and the impact on your business?</li> <li>! When was your BCP last tested?</li> </ul>	<ul style="list-style-type: none"> <li>! Build &amp; define your BCP</li> <li>! Ensure all staff receive training &amp; awareness of the business continuity plan and their specific roles &amp; responsibilities</li> <li>! <p><b>Contingency Planning for Critical Threats</b></p>	<ul style="list-style-type: none"> <li>! Business may wish to consider what actions they may take if a critical threat level was declared as part of their contingency planning.</li> </ul>	<ul style="list-style-type: none"> <li>! Ensure all security and staff are aware of the threat level whilst providing reassurance. Report any suspicious behaviour to the Anti-Terrorist Hotline.</li> <li>! <p><b>Persons acting suspiciously or conducting Hostile Reconnaissance</b></p>	<p>Are your staff aware of terrorist attack planning?</p> <ul style="list-style-type: none"> <li>! What activities constitute attack planning?</li> <li>! Who would that behaviour be reported to?</li> <li>! What details should staff be recording?</li> </ul>	<ul style="list-style-type: none"> <li>! Talk to local businesses about hosting an event for local staff.</li> <li>! Enrol your staff in a CT awareness programme.</li> <li>! Speak with your local borough Police Counter Terrorism contact for details on the next event.</li> <li>! <b>Extreme Weather</b>	<p>Do you have defined procedures in place for the dealing with extremes in weather (e.g. snow and ice, heat wave, storms and gales):</p> <ul style="list-style-type: none"> <li>! Do your premises have the facilities to cope with extremes in weather?</li> <li>! Do you have a contingency plan should your building or infrastructure become damaged by weather?</li> <li>! Would extreme weather (e.g. snow or ice) affect your staff's ability to get to work? Can you continue to meet the needs of your customers? Would you have issues with deliveries getting through?</li> </ul>	<ul style="list-style-type: none"> <li>! Have windows and doors have some type of shielding i.e. blinds</li> <li>! Check that you are adequately insured for weather damage.</li> <li>! Consider relocation of staff if damage occurs to an area.</li> <li>! Consider access to First aiders and basic supplies.</li> <li>! Are you aware if your premises are in a flood risk area (even if you are not at risk of flooding</li> </ul>	<ul style="list-style-type: none"> <li>! Consider preparing a flood kit.</li> <li>! Check you are</li> </ul>	<p>For advice about flooding, see the above extreme weather links</p>

<b>Disease</b>	<ul style="list-style-type: none"> <li>! Does your BCP cover loss of staff due to disease or pandemic</li> <li>! Does your business have the ability to allow staff to work from home in the event of a pandemic incident?</li> </ul>	<ul style="list-style-type: none"> <li>! Have your workforce practice good hygiene – Catch It, Bin It, Kill It</li> <li>! To educate staff to keep the workplace clean.</li> <li>! Have you tested your BCP fire procedures?</li> </ul>	<ul style="list-style-type: none"> <li>! Have you considered what advice you would give to staff?</li> <li>! Do you have procedures in place to contact staff away from the office</li> </ul>	<ul style="list-style-type: none"> <li>! Use the free Business preparedness tools and downloads.</li> <li>! Know which websites will be able to provide you with the information you need, depending on the type of incident.</li> <li>! Know when you should evacuate or invacuate.</li> <li>! Do staff have an awareness of tactics used by protest groups to mark buildings?</li> </ul>	<ul style="list-style-type: none"> <li>! Consider alternate exit plans from your building</li> <li>! When you are aware of upcoming action conduct regular building checks for markings</li> </ul>	<p>Follow your local Police Service online via their websites or twitter feeds to get up to the minute information</p>
<p><b>Transport Accidents and Industrial Accidents</b></p>	<ul style="list-style-type: none"> <li>! Do you have emergency contact details for your staff in the event of a transport incident?</li> <li>! Have you considered evacuation and shelter in your BCP?</li> </ul>	<ul style="list-style-type: none"> <li>!
